Preamble

Krishan Vishwa Vidyapeeth "Deemed to be University", Karad, Maharashtra, India (KVVDU) and Shri Sant Gajanan Maharaj College of Engineering, Shegaon, Maharashtra, India(SSGMCE) appreciate each other contribution in the field of academic and are of opinion that academic collaboration between the two shall be of mutual benefit to both the institutes and to the students of medical stream and engineering stream.







Krishan Vishwa Vidyapeeth "Deemed to be University", Karad, Maharashtra, India

A university declared U/s 3 of UGC Act, 1956 vide notification No.F-9-15/2001-U, 3 of the Ministry of Human Resource Development-Govt. of India. Accredited by NAAC with 'A+' Grade (CGPA: 3.39 on 4 point scale), An ISO 9001:2015 certified university, NIRF ranked university (73rd rank university in country and 42nd rank for medical college in country) Malkapur, Karad, Dist. Satara, 415539, Maharashtra, India.

Shri Sant Gajanan Maharaj College of Engineering, Shegaon (SSGMCE), one of the premier institutes in the field of engineering, was established in 1983 by Shri Gajanan Shikshan Sanstha, Shegaon. It is affiliated to Sant Gadge Baba Amravati University, Amravati, recognized by AICTE, New Delhi and approved by DTE, Maharashtra State, and Mumbai. Courses at SSGMCE are accredited by NBA (4-5 times), AICTE, New Delhi.

Objectives:

The collaboration shall aim to facilitate creation and advancement of knowledge with reference to the following points.

- Explore creation of interdisciplinary knowledge with integration of medical sciences and engineering technology.
- 2. Exchange the faculty for bilateral interdisciplinary learning.
- 3. Promote collaborative interdisciplinary research and development.
- 4. Merit based permission for use of each other for researcher and Ph.D. students.
- 5. Exchange student visit to enable medical student to acquire engineering knowledge that can be applied to add value to engineering profession.
- 6. Organizing seminars, conferences and workshops of mutual interest.
- 7. Invite each other's faculty.
- 8. Conduct research training programs.

Detailed terms and conditions for each activity shall be decided on mutual consent prior to planning and exchanging of the activity.

Coordination:

Each institute shall appoint one member of faculty to coordinate programs on its behalf. A coordination committee consisting of two senior officers, one teaching faculty administrative shall periodically review and indenting ways to strengthen coordination between two institutions.

Scope and Objective of MOU:

In order to make academic, research and consultancy development between the two institutions viz. KVVDU Karad and SSGMCE Shegaon, the scope and objective of MOU are defined as:

KVVDU and SSGMCE agree for Academic, Technical Research and Technical Cooperation between all their departments for implementation of this MOU.

Duration of MOU:

The duration of the MOU shall be for a period of 3 years from the date of signing the MOU.

Responsibilities of KVVDU and SSGMCE:

- The KVVDU and SSGMCE mutually agree to identify the various areas of interest and depute faculty on as per requirements for conducting Technical Consultancy Research in various departments of KVVDU and SSGMCE. Both the institutions will meet the TA/DA of their respective members visiting the other institution. The host institution will provide all boarding and lodging facilities to the visiting members.
- Both the parties i.e. KVVDU and SSGMCE will organize technical competitions, conferences, workshops, seminars, quiz's etc. Such programs will be conducted by both the institutions regular basis as and when called for and informed to each other in advance.
- KVVDU and SSGMCE mutually agree to provide expertise to establish and develop laboratories, research centres, data centres, other networking sites and medical relief centres etc.
- SSGMCE will provide consultancy to KVVDU in advancement of different departments in the field of Information Technology, Mechanical, Electrical and Electronics & Telecommunication Engineering, Computer Engineering, etc.
- SSGMCE will provide expertise in setting up different servers, labs, websites, apps and hardware & software equipment and devices, and will help in procuring computer and IT devices like 3D printers, scanners and other state of art devices as per the requirement of the medical world.
- KVVDU on its own or with the help other agencies conduct health camps and provide
 financial discounts of 30% in its hospital to the staff and students of SSGMCE in health
 check-up and hospital treatment.
- KVVDU and SSGMCE will work on health information sharing for projects and combined projects in IT and medicine and different surveys in Medical Science and IT.
- KVVDU and SSGMCE will organise blood donation and health check-up camps with mutual understanding.
- KVVDU and SSGMCE will start consultancy projects, research and training for health related electronics and mechanical devices.
- KVVDU and SSGMCE will help each other to conduct short courses, cultural projects, study tours.
- 11. Areas for R & D projects, Design and Consultancy shall be identified and joint proposals shall be submitted to various funding agencies like MHRD, DST and AICTE and other organization of national and international repute.
- KVVDU and SSGMCE can file IPR jointly. KVVDU can give the internship to the SSGMCE students in hybrid mode.

Amendment to the MOU:

No amendment or modification of this MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to an amendment of this agreement. The modification/change shall be effective from the date on which they are made/executed unless otherwise agreed to.





Arbitration Clause:

Each activity will be planned and executed on mutually agreeable terms and conditions and therefore is no likely hood of any dispute. However any dispute arise, the Vice Chancellor Krishan Vishwa Vidyapeeth "Deemed to be University", Karad, and Hon'ble Principal, Shri Sant Gajanan Maharaj College of Engineering, Shegaon will jointly resolve in spirit of independence, mutual respect and shared responsibility.
